If so, how about joining the next Vet SIG quarterly meeting (April 30th)? We will present the first in a series of "VMW tasters", with a talk titled "Sweet Secrets of Honey in the Air: Anatomy of an Evidence-based Veterinary Medicine (EBVM) Report" by veterinarian-turned-freelance-medical-writer Louisa Marcombes. Drawing from her experiences evaluating evidence on the use of honey for wound healing in dogs, she discusses the challenges EBVM poses to medical writers and the pitfalls to avoid when communicating EBVM to a veterinary or lay audience.
