3.	President's Report
	President Satyen Shenoy (SS) welcomed everyone to the meeting and made the following report:
	 SS recapped what has been achieved during his Presidency during 2022 Growth in membership: 1278 in Feb 2022 to 1418 in Feb 2023. Two F2F conferences in hybrid mode. New programmes: mini-symposium, ESS, Expert Discussion Groups. Release of Getting Into Medical Writing guide. Collaborations: GPP2022, CORE Reference, JPS. Salary and Compensation Survey, Freelance Business Survey. Support for local networking: the Italian experience. Development of Strategic Plan 2023-27.

4.	Treasurer's Report
4a.	Treasurer, Sarah Choudhury (SC), advised the audience that the draft set of audited Accounts for 2022 had been circulated in the AM pack. SC further advised that the financial figures presented today had been rounded off to the nearest 100 euros. SC confirmed that as the reserves reached over 1 million Euros it has been advised that we need to reduce this amount and therefore we have invested and will continue to invest in the website, specialist interest groups and the journal. Members would today be asked to vote to adopt the 2022 annual accounts, the 2023 budget and to
	appoint the auditors for 2023.
	SC presented the 2022 accounts, noting the healthy conference income of €437,600k and a good income from adverts/sponsorship. Income from membership subscriptions was at €187,900. EMWA's reserves were at just over €1 million. Deficit (pre-tax) for year end 2022 = -€64,900. Equivalent to - 9.97% loss (Expected and intended).
4b.	SC then presented the budget for 2023 to delegates.
	SC confirmed that the projected income for 2023 is €770,000 and budgeted expenditure is €840,000 Rounded to nearest 1000 yielding a projected deficit of €-71,800 (-9.3.0%)" before tax. There will be continued investment within the website, specialist interest groups and the journal.
	It was also noted that EMWA has signed a further one-year contract with HO to the end of 2024 and the plan will be to send this out to tender as this will be good business practice.
	Reducing fees – over the last seven years, EMWA have not increased any costs and have absorbed all inflation costs. The plan is to look at travel costs etc for the conferences before looking at reducing the fees.
